#### **Eucalyptus Resolved**

All gathered at the September Community Meeting agreed to have State Parks and the California Department of Forestry (CDF) go forward with removing the Eucalyptus trees along the north side of the Caspar Headlands. Beginning this fall, or in the early spring before nesting birds become a concern, CDF will begin cutting the trees. Caspar Community volunteers will prepare to sell the bucked trees as firewood. Care will be used to mitigate impacts on any archeological and historical resources when moving the firewood. An ongoing effort, entailing manual removal of new sprouts, will ensue that the Eucalyptus will not grow from the stumps. No herbicides will be used

## **Gorse Report**

Congratulations to all the Caspar volunteers who cut gorse at the Caspar Headlands State Park. Our work for this year is over. We've cut and piled all the gorse, and State Parks has agreed to burn the piles. We plan to return in the spring and manually remove the sprouts without the use of any herbicides. This manualno herbicide project is working well for Caspar residents, Parks, and the environment. Hope you enjoy your walks, bike rides and picnics on the headlands.

Zac Zachary and I met with California State Parks Regional District Superintendent Marilyn Murphy and Bill Maslach, project manager, to deliver a petition with 237 signatures against the use of herbicides at Jughandle State Park and to discuss alternative methods of gorse removal. According to Ms. Murphy, Parks has already contracted a company to use Garlon on the sprouting gorse and Scotch Broom plants at Jughandle. The company sprayed some areas about a year ago and will spray again when the sprouts come up after recent machine removal and burning. The contract, which runs through the end of June, cannot be broken without losing the agreed payment. Spraying 27 acres of European Beachgrass at Inglenook Fen/Ten Mile Dunes is also in the contract.

Murphy has agreed that volunteers could take responsibility for a portion of Jughandle that they think they could handle; this area would not be sprayed. Volunteers would manually remove sprouting gorse plants in that area on an ongoing basis. Parks would continue to use Garlon on the rest of Jughandle (at least for the term of this contract.)


We are hoping that there may still be a way to terminate this contract and use the money to hire workers to remove sprouts manually. A reading of the contract indicates that the "State reserves the right to terminate this agreement subject to 30 days' written notice to the Contractor."

Zac will continue work on this project and has the backing of the Mendocino Environmental Center. Anyone interested in becoming involved is invited to talk with him at the Caspar Community Meeting or contact him at 964-3621.

Since Jughandle is adjacent to Caspar, many local people, as well as Park visitors, will be affected by the amount of herbicide to be sprayed repeatedly over many years, on the 15 or more acres until the gorse is eliminated. That's a lot of land to be covered with Garlon. Scary. —Bette Goldfarb

# Caspar Uplands Trail on MLT property

Mendocino Land Trust (MLT) and State Parks will be sharing their progress on planning for the segment of the California Coastal Trail that will be located on MLT's 76-acre property, which

extends from Caspar Beach to east of Point Cabrillo Light Station. The trail will link the Caspar Headlands and the Light Station. The Caspar Headlands was conveyed from MLT to State Parks in 2002, and it is anticipated that the South Parcel will be conveyed to State Parks in 2009 with a completed trail plan and updated Management Plan. MLT and State Parks would like community input into the trail design and management plan updates and will be discussing the trail layout, construction, resource protection, management and stewardship at the Caspar Community Meeting.

Another possible topic for discussion the Community Meeting is the creation of a Caspar Headlands and Beach Advisory Group, which would establish communication among Caspar and Caspar South residents and State Parks, and address matters such as a bridge over Caspar Creek, fires on Caspar Beach, and a dog-romping area.
